- The shares were sold at prices ranging from \$32.24 to \$32.58. The Reporting Person will provide upon request to the SEC, the issuer or security holder of the issuer, full information regarding the number of shares sold at each separate price.
- The Stock Options will vest and become exercisable in a series of 48 successive equal monthly installments measured from February 27, 2023, subject to Reporting Person's continued employment on each anniversary.
